TITLE IV: CENTRAL COAST HERITAGE PROTECTION ACT (H.R. 973 - CARBAJAL)

Supports the Central Coast's Tourism Economy While Protecting Unique Ecosystems and Access to Clean Water

Summary of the Central Coast Heritage Protection Act

Title IV would designate approximately 287,500 acres of public land in the Carrizo Plain National Monument and the Los Padres National Forest as components of the National Wilderness Preservation System. The creation of two potential wilderness areas will allow for the remediation of non-conforming uses, and two scenic areas will preserve Central Coast vistas. The title also protects 227 river miles of clean, free-flowing water under the National Wild and Scenic Rivers System. Local recreation economies would also benefit from the designation of the approximately 400-mile Condor National Scenic Trail in Central California, as well as efforts to expand mountain biking and off-highway vehicle access. A special provision is included to guarantee tribal access to wilderness areas for cultural and religious purposes.

Title IV would:

- Designate approximately 287,500 acres of new, expanded, or potential wilderness areas.
- Designate approximately 31,882 acres of public land as scenic areas.
- Add approximately 227 river miles to the National Wild and Scenic Rivers System.
- Create a thru-hiking experience along the 400-mile Condor National Scenic Trail to connect the wilderness areas in the northern and southern portions of the Los Padres National Forest.
- Study new opportunities for thru-hiking, mountain biking, and off-highway vehicle use.
