

# TITLE VI: WILD OLYMPICS WILDERNESS AND WILD AND SCENIC RIVERS ACT (KILMER – H.R. 2642)

Supports Access to Clean Water, Critical Wildlife Habitat, Recreational Opportunities and Economic Growth

### Summary of the Wild Olympics Wilderness and Wild and Scenic Rivers Act

Title VI would designate 19 Wild and Scenic Rivers spanning more than 464 river miles from Olympic National Park and the surrounding Olympic National Forest, designate 126,544 acres of wilderness on the Olympic Peninsula, and protect another 5,346 acres as potential wilderness to allow for forest restoration under current management plans. The title would safeguard clean water, protect old-growth temperate rainforest, and preserve fish and wildlife habitat. Title VI also promotes economic growth by expanding recreational opportunities in the region and has the support of a broad and diverse coalition of stakeholders.

#### Title VI would:

- > Designate approximately 131,900 acres as new, expanded, or potential wilderness areas.
- ➢ Add approximately 464.5 miles to the National Wild and Scenic Rivers System.
