 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Wild Free-Roaming
- 5 Horses and Burros Protection Act of 2022".

3 (a) CONGRESSIONAL FINDINGS AND DECLARATION
4 OF POLICY.—Section 1 of the Wild Free-Roaming Horses
5 and Burros Act (16 U.S.C. 1331) is amended by striking
6 "in the area where presently found, as".

7 (b) DEFINITIONS.—Section 2 of the Wild Free8 Roaming Horses and Burros Act (16 U.S.C. 1332) is
9 amended—

10 (1) in subsection (a), by striking "by him" in11 each place it occurs;

(2) in subsection (b), by striking "wild freeroaming horses and burros" and inserting "wild
free-roaming horses and burros' or 'wild free-roaming horses or burros";

18 "(d) 'population' means all wild free-roaming horses19 and burros existing within the boundaries of a herd man-20 agement area or range;";

10	of a procedure involving an incision and either—
11	"(1) the removal of reproductive organ(s); or
12	((2) the alteration of reproductive organ(s) or
13	surrounding tissue;
14	"(i) 'fatally injured or terminally ill' means exhibiting
15	an acute or chronic illness, injury, physical condition, or
16	lameness that, as determined by a licensed veterinarian—
17	((1)) precludes an acceptable quality of life due
18	to pain or suffering; or
19	"(2) has a minimal chance of recovery;
20	"(j) 'appropriate management level' means the level
21	at which the number of wild free-roaming horses and bur-
22	ros in a population are able to—
23	"(1) sustain themselves in a healthy condition;
24	"(2) produce healthy foals;
25	"(3) maintain healthy genetic diversity; and

1	"(4) sustain a thriving natural ecological bal-
2	ance;
3	"(k) 'animal welfare or wild horse organization'
4	means an organization—
5	"(1) described in section $501(c)(3)$ of the Inter-
6	nal Revenue Code of 1986 (26 U.S.C. $501(c)(3)$);
7	((2) exempt from taxation under section 501(a)
8	of such Code; and
9	"(3) the mission and practice of which includes
10	the humane treatment of wild horses and burros;

12	"(l) 'herd management area' means a designated area
13	of public lands established for the maintenance and pres-
14	ervation of wild free-roaming horse and burro popu-
15	lations.".
16	(c) Powers and Duties of Secretary.—Section
17	3 of the Wild Free-Roaming Horses and Burros Act (16
18	U.S.C. 1333) is amended—
19	(1) in subsection (a)—
20	(A) by striking "All wild free-roaming
21	horses and burros are hereby" and inserting the
22	following:
23	"(1) All wild free-roaming horses and burros
24	are hereby";

1	(B) by striking "he may designate and
2	maintain specific ranges on public lands as
3	sanctuaries for their protection and preserva-
4	tion, where the Secretary after consultation"
5	and inserting "the Secretary may designate and
6	maintain specific ranges on public lands as
7	sanctuaries for the protection and preservation
8	of wild free-roaming horses and burros, after
9	consultation";
10	(C) by striking "He shall consider" and in-
11	serting "The Secretary shall consider";
12	(D) by inserting "wild free-roaming horses

8	"(B) taking action as expeditiously as
9	practicable to correct, prevent the recurrence of,

14	immunocontraception vaccines, to achieve on-range
15	management goals.
16	"(B) In carrying out this paragraph, the Sec-
17	retary may contract with or enter into partnerships
18	with nonprofit organizations (with preference given
19	to veterans organizations and animal welfare or wild
20	horse organizations trained or otherwise certified in
21	the humane management or population control of
22	wild horses and burros).
23	"(C) Nothing in this Act authorizes the Sec-
24	retary to surgically sterilize any wild free-roaming

5 "(C) In the absence of the information con-6 tained in clauses (i) through (v) of subparagraph 7 (B), a determination to remove excess animals from 8 public lands must be made on the basis of all infor-9 mation currently available to the Secretary that such 10 removal is necessary.

11 "(D) After publishing in the Federal Register a 12 determination to remove excess animals from public 13 land, the Secretary may cause excess animals to be 14 humanely captured and removed for private mainte-15 nance and care for which the Secretary determines 16 an adoption demand exists by qualified individuals 17 prior to removal, except in the case of a removal 18 pursuant to subsection (j).

"(E) The Secretary must ensure humane treatment and care of the animals (including proper
transportation, feeding, and handling), including by
requiring that—

23 "(i) not more than four animals may be24 adopted per year by any individual; and

1	"(ii) each individual adopter execute an ap-
2	propriate attestation, pursuant to section 1001
3	of title 18, United States Code, affirming that
4	the adopter will not cause or allow an adopted

7 "(g) The Secretary may not administer a program
8 through which potential adopters may be offered a cash
9 or monetary incentive for successful completion of the
10 adoption process.

11 "(h) The Secretary may not destroy or authorize the
12 destruction of wild free-roaming horses or burros unless
13 the Secretary—

"(1) determines, based on the evaluation of a licensed veterinarian, that the wild free-roaming horse
or burro is fatally injured or terminally ill; and

17 "(2) ensures that the wild free-roaming horse18 or burro is euthanized in the most humane manner19 available.

20 "(i) The Secretary may not—

"(1) process, authorize to be processed, or ship,
move, deliver, receive, possess, purchase, sell, donate,
or transport for processing any animal that is or
was at any point during its life a wild free-roaming

horse or burro, or the remains thereof, into commer cial products; or

3 "(2) carry out any activity described in para4 graph (1) if the Secretary has reason to believe the
5 animal will be processed into commercial products as
6 a result.

7 "(j) The Secretary may temporarily remove wild free8 roaming horses and burros from public lands if the imme9 diate health or safety of those wild free-roaming horses
10 or burros is threatened.

"(k) Except in cases of removal under subsection (j),
if the Secretary removes wild free-roaming horses or burros, the Secretary shall provide a public notice on a public
website of the Secretary's department at least 30 days before the planned removal.

16 "(l) The Secretary shall—

17 "(1) track the number of wild free-roaming
18 horses and burros injured or killed during gathering
19 and holding, along with a brief description of the in20 jury or cause of death, in a centralized database sys21 tem; and

22 "(2) publish such information on a public23 website of the Secretary's department.".

24 (d) PRIVATE MAINTENANCE; NUMERICAL APPROXI-25 MATION; STRAYS ON PRIVATE LANDS; REMOVAL; DE-

STRUCTION BY AGENTS.—Section 4 of the Wild Free-1 2 Roaming Horses and Burros Act (16 U.S.C. 1334) is amended-3 (1) by inserting "or returned to public lands" 4 5 after "arrange to have the animals removed"; 6 (2) by inserting "pursuant to section 3(h)" 7 after "by the agents of the Secretary": 8 (3) by striking "his private lands" and inserting 9 "the landowner's private lands"; 10 (4) by striking "if he does so" and inserting "if 11 the private landowner does so"; 12 (5) by striking "removed or enticed from the 13 public lands" and inserting "caused to leave public 14 lands for the purpose of converting the animals into 15 private property (including by removal or entice-16 ment)"; and 17 (6) by striking "and supply him" and inserting 18 "and supply the Secretary". 19 (e) COOPERATIVE AGREEMENTS; REGULATIONS.— 20 Section 6 of the Wild Free-Roaming Horses and Burros 21 Act (16 U.S.C. 1336) is amended— 22 (1) by inserting ", nonprofit organizations, pri-23 vate entities," after "landowners"; and 24 (2) by striking "he deems" and inserting "the Secretary deems". 25

5 the Wild Free-Roaming Horses and Burros Act (16
6 U.S.C. 1338a) is amended—

(1) by striking "may use or contract for the use 7 8 of helicopters or, for the purpose of transporting 9 captured animals, motor vehicles. Such use" and in-10 serting "shall prioritize use of the most humane, 11 passive techniques, such as bait-and-trap techniques, 12 for any capture of wild free-roaming horses and bur-13 ros. The use of non-passive techniques with respect 14 to the capture of wild free-roaming horses and bur-15 ros"; and

16 (2) by striking "fixed-wing aircraft, or heli-17 copters, or to" and inserting "or".

(h) LIMITATION OF AUTHORITY.—Section 10 of the
Wild Free-Roaming Horses and Burros Act (16 U.S.C.
1339) is repealed.

(i) JOINT REPORT TO CONGRESS; CONSULTATION
22 AND COORDINATION OF IMPLEMENTATION, ENFORCE23 MENT, AND DEPARTMENTAL ACTIVITIES; STUDIES.—Sec24 tion 11 of the Wild Free-Roaming Horses and Burros Act

(16 U.S.C. 1340) is amended by striking "he might" and
 inserting "the Secretary might".

3 SEC. 3. GAO REPORT.

4 Not later than 1 year after the date of the enactment
5 of this Act, the Comptroller General shall submit, to the
6 Committee on Natural Resources of the House of Rep7 resentatives and the Committee on Energy and Natural
8 Resources of the Senate, a report that describes—

- 9 (1) humane alternatives to the use of heli10 copters and fixed-wing aircraft in managing wild
 11 free-roaming horse and burro populations;
- (2) job creation opportunities presented by theuse of such humane alternatives; and
- 14 (3) the effects of aircraft, including unmanned
 15 aircraft systems, on wild free-roaming horse and
 16 burro populations.
