HISTORY OF EFFORTS TO PROTECT THE GRAND CANYON



Congress establishes Grand Canyon National Park.

February 26, 1919

In the 110th Congress, Rep. Raúl Grijalva (D-Ariz.) introduces the Grand Canyon Watersheds Protection Act of 2008 (H.R. 5583) to withdraw approximately one million acres near the Grand Canyon from mineral exploration.

The Southern Nevada Water Authority sends a letter to Interior Secretary Kempthorne expressing concerns about uranium mining around the Grand Canyon.

Rep. Grijalva holds a field hearing at the Grand Canyon on "Community Impacts of Proposed Uranium Mining near Grand Canyon National Park."

March 28, 2008

The House Committee on Natural Resources votes in favor of a resolution requiring the Interior Secretary to withdraw public lands surrounding the Grand Canyon from new uranium mining.

June 25, 2008

In the 111th Congress, Rep. Grijalva introduces the Grand Canyon Watersheds Protection Act of 2009 (H.R. 644) to withdraw approximately one million acres near the Grand Canyon from mining.

Rep. Grijalva sends a letter to President Obama calling upon the administration to protect the Grand Canyon from future mining.

August 12, 2009

Interior Secretary Salazar visits the Grand Canyon and announces a two-year "time-out" from new mining in watersheds surrounding Grand Canyon National Park.

President Obama and family visit the Grand Canyon.

August 14, 2009

The U.S. Geological Survey releases a report detailing the potential effects of uranium mining in the Grand Canyon region.

In the 112th Congress, Rep. Grijalva introduces the Grand Canyon Watersheds Protection Act of 2011 (H.R. 855) to withdraw approximately one million acres near the Grand Canyon from mining.

March 1, 2011

Rep. Grijalva holds a field hearing at the Grand Canyon entitled "On the Edge: Challenges Facing Grand Canyon National Park."

Interior Secretary Salazar issues a 20-year moratorium on new mining claims for approximately one million acres of public land surrounding Grand Canyon National Park.

January 9, 2012

In the 113th Congress, Rep. Grijalva introduces the Grand Canyon Watersheds Protection Act of 2013 (H.R. 1350) to withdraw ~one million acres near the Grand Canyon mining.

In the 115th Congress, Rep. Grijalva reintroduces the Greater Grand Canyon Heritage National Monument Act (H.R. 360), which would establish a national monument and make permanent the 20-year ban on new uranium claims.

In the 114th Congress, Rep. Grijalva introduces the Greater Grand Canyon Heritage National Monument Act (H.R. 3882), which would establish a national monument and make permanent the 20-year ban on new uranium claims.

Nov. 1, 2017 On the Centennial anniversary of Grand Canyon National Park, Rep. Grijalva introduces the Grand Canyon Centennial Protection Act (H.R. 1373) in the 116th Congress to permanently withdraw one million acres of public lands surrounding the Grand Canyon from new mining claims.

Trump administration,

the U.S. Forest Service takes the first step to lift the Grand Canyon uranium ban, following an executive order recommending revision of the Grand Canyon mineral withdrawal.

In the 117th Congress, Rep. Grijalva introduces the Grand Canyon Protection Act (H.R. 1052) to permanently protect the Grand Canyon from new uranium mining.

The Grand Canyon Protection Act passes the House as part of H.R. 803, Protecting America's Wilderness Act, on a bipartisan vote.

The Grand Canyon Protection Act passes the House for the second time on a bipartisan vote

The Grand Canyon Tribal Coalition calls on President Biden to designate the Baaj Nwaavjo I'tah Kukveni Grand Canyon National Monument

April 11, 2023

The Grand Canyon Protection Act passes the House for the third time on yet another bipartisan vote.
